

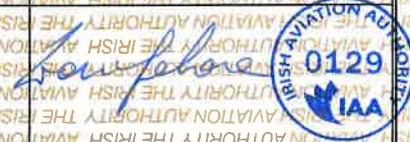

ANNEX NUMBER 177

The terms of approval conferred under Approval Number IAA/1172/11 and any related conditions are as follows:

1. PRIVILEGES

The procurement, storage and distribution of aircraft parts or materials intended for fitting to aircraft in service, to aircraft, or undergoing maintenance, inspection, test, overhaul, modification or repair.

2. RELATED CONDITIONS

- (a) This approval is subject to the organisation responsible for the approved premises operating in compliance with their approved Exposition (Procedures) Manual at latest revision, which may be approved in whole or in part by the Irish Aviation Authority.
- (b) The organisation responsible for the approved premises shall remain in compliance with the storage/handling recommendations as defined by the parts / material / accessories manufacturers.
- (c) The release of components / material / accessories must be carried out in accordance with the approved Exposition (Procedures) Manual.

3. LIMITATIONS

- (a) This approval is limited to the installation as defined in the exposition.
- (b) This approval in no way authorises the use of aircraft parts or materials in any particular aircraft or engine or aircraft/engine combination. The end user is responsible for ensuring the parts or materials are approved to be used on the aircraft or engine or aircraft/engine combination concerned.
